BUDGET AND TREASURY: WITHDRAWALS FROM MUNICIPAL BANK ACCOUNT FOR THE QUARTER ENDED 31 DECEMBER 2017

1. Purpose

The purpose of this item is to report to the Council on specific withdrawals from the municipal bank account in terms of the Municipal Finance Management Act, Act No. 56 of 2003.

2. Legislative requirements

Section 11(4) of the MFMA:

"The accounting officer must within 30 days after the end of each quarter –

- a) table in the municipal council a consolidated report of all withdrawals made in terms of subsection 1(b) to (j) during that quarter; and*
- b) submit a copy of the report to the relevant provincial treasury and the Auditor-General*

"Attached as Annexure 'A' is a report on the withdrawals from the municipal bank account for the quarter ended 31 December 2017.

The following information should be noted for the quarter ended 31 December 2017:

Section 11(1)(b): Expenditure that were authorised in terms of section 26(4) of the MFMA
