SUPPLY, DELIVERY AND INSTALLATION OF HOT WATER STORAGE TANKS AT JEFFREYS BAY CARAVAN PARK

SPECIFICATION/SCOPE OF WORK:

HOT WATER STORAGE TANKS – 1100 x 2 N°

Manufacture and install 1 x Complete Electronic Panel Elements and controls for both (X2 Hot Water Storage Tanks).

Supply and Install all the necessary piping and consumables in each boiler house, completed.

Supply and install lagging and cladding of all piping in Boiler house completed.

All piping in boiler house to be renewed and redundant piping must be taken out.

Specific guarantees on electrical equipment and piping as well as on the work to be carried out in general – (compulsory).

SPECIAL REQUIREMENTS

Supply and install factory built by a specialist manufacturer insulated thermal hot water storage tanks (2 X 1100L) of the volume, temperature and pressure rating as specified in the technical schedules.

The tank shall be the vertical standing, round type with “domed” ends on top and bottom. The vertical round tank shell have a minimum thickness of 5mm. The tank shall be fitted with a 450mm manhole with a blank flange for inspection.

The tank shall be supported by a minimum of four support legs. The welding manufacturing shall be in accordance with ASMEVIII. The tank shall be supplied with factory fitted and suitable hoisting lugs.

Welding joints shall be "staggered" to avoid concentration of welding joints which could create "hot spots". Welded sockets shall be in accordance with ASA B16-11 and shall be long enough to extend at least 50mm outside the tank to penetrate the tank insulation up to the cladding surface. (Sockets are 8 x 50 3000lbs for longer life span.

Over and above the referred standards the tank shall have a test pressure, a working pressure and an operation temperature.

Fittings, Controls, Safeties and Instruments

The tank shall be manufactured with sufficient sockets to accommodate the connections for the controls and safeties and other devices as stipulated in the technical schedules including but limited to: (Sockets of calorifiers are to be of a minimum of 50mm as accordance to the new vessel under pressure Act)

8 - 8x50mm 3000lbs sockets for drain feed supply, return, temp probe, safety, solar equipment

1 - Ø 50mm cold water inlet bottom side

1 - Ø 50mm water connection on the top

1 - Ø 25mm drain valve

1 - Ø 15mm air vent on the top of the tank

1 - Vacuum breaker

2 - 25mm Pressure relief valves with suitable copper "blow off" discharge piping to the nearest drain

1 - Ø 15mm bottom entry 100mm glycerin filled pressure gauge with stainless steel casing

1 - Ø 25mm inlet and outlet piping for the electric stand-by heating

The tank shall be factory fitted with suitable hoisting lugs.

The tanks shall be factory fitted with 4 X Anodes in each

External Finish (Steel tanks only)

After completion of the tank manufacturing, and prior to applying tank insulation, the external surface shall be cleaned to remove grease and dirt and wire brushed and scraped to remove all the rust and scale before applying two coats of suitable red oxide type priming paint.

Tank Insulation

The tank shall be insulated using 50mm fiberglass blankets affixed to the tank with "pin straps", "spikes" to prevent sagging of the fiberglass insulation.

The fiberglass insulation shall be covered with "removable" galvanized sheet-metal. The insulation and the cladding may be applied on the site after the tank has been situated in its final position to prevent damages to the insulation.

For hot water applications gate valves are not approved (compulsory).

Valves will be of the "ballcock" type, rated for the specified pressure and temperature conditions.

Fixtures and Fittings

The tank shall be supplied with all necessary control and safety devices, immersion heaters, instrumentation (pressure gauges and thermometers), valves and other devices capable to meet the specified pressure and temperature requirements.

For hot water applications gate valves are not approved (compulsory).

Valves will be of the "ballcock" type rated for the specified pressure and temperature conditions.

Test Procedures:

In view of the pressure and temperature ratings the following test procedures shall be strictly adhered to:

1. Tank to the factory pressure tested with water at the rated test pressure. A certificate issued by a Government approved inspection authority for approval.
2. After the tank has been installed and piping connected, the tank will be pressure tested full of water on the site up to the rated test pressures with the tank pressure relief valve plugged off.
3. The tank itself is also fitted with at least one pressure relief valves each adequately sized to allow sufficient by the electric heater elements. The tank to be isolated and pressure tested to make sure that the pressure relief valve opens as soon as the tank pressure reached the rated relief pressures.
4. No electrical supply to the heat pumps and/or electric heating elements should be connected before all the above and necessary pressure test have been successfully completed and approved.
5. As part of the commissioning procedures we are required to submit a signed test report for review and approval as documentary evidence that all test have been carried out in accordance with the requirements.

ELECTRICAL PANEL

There will be one electrical panel for each calorifier and necessary pumps. It will have 1 X temperature controller, indication lamps and lockable isolator (all switch gear included).

All equipment delivered to site shall be adequately protected against damage that can be expected on a building site. Protection against weather is the responsibility of the main contractor regarding building and wet works.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated to not exceed R1 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close

Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

- 1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- 2.1 **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working

or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;

- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right) \quad \text{or} \quad P_s = 90 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.

- (ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form.
- (iii) In the event of a contract being awarded as a result of points claimed as shown in paragraph 7, the contractor may be required to furnish documentary proof to the satisfaction of the purchaser that the claims are correct;
- (iv) If the B-BBEE status level of contribution has been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the purchaser may, in addition to any other remedy it may have –
 - (a) disqualify the person from the bidding process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;

- (d) restrict the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution

Bid rigging is, therefore, an agreement between competitors not to compete.
