SPECIFICATIONS ON FIRE FIGHTING TRAILER.

SCOPE

This document establishes the type of fire fighting trailers generally used by the Fire Department for bush and informal structure fire fighting on a daily bases.

The general requirements and standard requirements will be part of this tender document.

All prices must exclude VAT, valid for 90 days. Supply and service dates will be provided in writing to the relevant department.

STATUTORY REQUIREMENTS

The trailer must be built by a registered company. Trailer must be fully roadworthy after completion. Trailer must be manufactured by a registered trailer manufacturer and be compliant to SABS standards.

SERVICE REQUIREMENTS

- Tenderers shall provide detailed information on their ability to perform routine repairs to trailers after delivery.
- Tenderers shall state what the maximum delivery time will be to provide spare parts.

GUARANTEE

A twelve month warranty on unit as a whole to be provided.

MANUALS

The successful tenderer shall supply operating manuals.

MINIMUM SPECIFICATIONS OF FIRE FIGHTING TRAILER

1. Scope

Fire Fighting trailer with a water tank of 1000 litres, pump, electric and manual pump motor, equipment boxes and equipment straps.

2. Trailer and Frame

- Wheels and rims to be 5.0 x 5" fitted with new 215 x 15" 8 ply off road tyres.
- Trailer fitted with sigma heavy duty coupler that incorporates a hand brake in the tow hitch.
- An axle with a minimum load of 1800 kg, fitted with a 10 blade leaf spring, heavy duty shock absorbers and auto reverse facility to ensure safe braking under extreme conditions. The braking system must comply with SABS 1207.
- The final design of the trailer must conform to all the relevant Road and Traffic Regulations.
- All electrical systems to strictly comply with SABS standards.
- Steel splash plate fitted in front of unit to protect pump and engine.
- Total frame to be painted fire service red.
- Licencing disc holder and number plate holder to be fixed to the trailer.

3. Water Tank

- 1000 litre roto-moulded polyethylene water tank with a wall thickness of at least 8mm
- A 400 mm manhole with quick screw on lid fitted to top of tank. The tank suitably vented to prevent collapse while being emptied.
- The tank and trailer design build in such that the tank to chassis relies with 8 ton webbing straps which are fastened over the top of the tank.
- The tank must also be securely mounted with front and rear support foot mountings, to ensure stability of tank during transportation.
- The inside of the tank to be fitted with baffles to reduce water surge during transportation.
- The tank must fit with a fast draining point of 50mm.

4. Fire Fighting pump and engine

- Engine to not less than 13 hp recoil start, 4 stroke
- Two stage pump, delivering at least 500 litres per minute and high pressure up to 11Bars.
- The pump must be a centrifugal high volume self priming pump

5. Hose reel, hose and nozzle

- A robust all steel double base mounted reel, with rotary seal bolted to the rear of the tank top. Quick coupled to pump with 30 meter cotton braided high pressure hose.
- A ratchet type crank handle to fit the reel.
- One mini jet spray adjustable branch nozzle with adjustable flow of 37-150lpm @ 7 Bar, fitted to end of hose. (Akron or similar)

6. Storage facilities

- The unit to be fitted with a lockable storage box on either side of trailer. Each locker must have sufficient space for a standard standpipe (2m), key and bar and high enough for a 4,5 kg DCP to stand upright in the storage box. Brackets to be fitted on trailer to tie down at least 3 fire beaters and at least two 16 Liter Knapsack tanks.

7. Plumbing, discharge and Suction

- Discharge configuration to be as follows:
- Hose reel discharge controlled via a ball valve from the pump
- Layflat hose discharge for normal fire fighting with 65 mm hose, BIC coupler fitted to the pump with ball valve control
- The pump to be able to perform normal tank to pump operation as well as outsource suction from a 5 meter x 40mm h/d heliflex rubber hose with fine strainer.

8. Warranty

A twelve month warranty on the unit as a whole to be provided.

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated to not exceed R1 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close

Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

- 1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- 2.1 **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad -Based Black Economic Empowerment Act;
- 2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;

- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
