A) SCOPE:

- **Machine dimension : 23.5 "W x 9" H x 23" D (60cmW x23cmH x 58cm D)**
- **Weight: +/- 57lbs (26kg), with packaging +/- 68 lbs (30.8kg)**
- **Spine Lengths: Max 12"(30.5cm) (A4); Min. 6"(15.24cm)**
- **Spine Thickness: Narrow, Medium, Wide**

The Service Provider shall:

- Guarantee to keep sufficient stock of spares in RSA over a period of (3 years) for scheduled maintenance of the equipment, according to the manufactures maintenance schedule.

- Supply proof of their technical ability to repair and service the equipment required.

Suppliers shall state in their quote what guarantee is offered. If no guarantee is stated, it will be assumed that it is 24 months, which will include labour, spare parts and company travelling expenses necessary to perform guarantee related repair.

All guarantee certificates shall be submitted with the quote documents.

C) MANUALS:

The successful bidder shall supply the manuals free of charge for the unit as well as the accompanying equipment on the unit, where applicable.

The operator's manuals, maintenance manuals and spare parts manual may be made up of:

One master copy of each from which clear photo copies can be reproduced and one clear copy of each.

D) TRAINING:

The successful bidder shall provide training in the use and maintenance of the machine and equipment supplied.

E) SERVICEABILITY:

The apparatus shall be designed so that all the manufacturers recommended routine maintenance checks can be performed by the operator.

Apparatus components that interfere with repair or removal of the major components shall be attached with fasteners, such as cap screws and nuts, so that the components can be removed and installed with hand tools. These components shall not be welded or otherwise permanently into place.

F) RELIABILITY:

The material used for construction of the machine shall be selected for the proven reliability in service. This requirement shall include all equipment and ancillary equipment forming an integral part of the finished machine.

G) MAINTAINABILITY:

All components used in the manufacture of the machine shall be selected for ease maintenance and shall be easily accessible for servicing.
