- In order to claim Preference points a valid original or certified B-BBEE Status level Verification certificate from an **SANAS** registered verification agency or a registered auditor approved by the Independent Regulatory Board of Auditors (IRBA) must be submitted to validate the claim, **No B-BBEE Status Level Verification Certificate- No points to be claimed.(updated regulations apply)**
