**TENDER FOR SUPPLY AND DELIVERY OF ROAD TRAFFIC SIGNS TO KOUGA
LOCAL MUNICIPALITY**

The Kouga Municipality is inviting suitably and competent suppliers or service providers to bid for Supply and Delivery of Road Traffic Signs for Kouga Local Municipality. The contract will run for two (2) years with an option to extend subject to performance of the supplier or service provider.

INVITATION AND SCOPE OF WORK:

- a) All road signs to comply with the National Road Traffic Act (93/1996) and with specifications as set out in the Road Traffic Signs Manual.
- b) All road signs and cones must be SABS approved.
- c) Defects liability period of 6months will be applicable.
- d) Bidders must have sufficient stock of all items quoted for the duration of the contract.

CONDITIONS OF THIS TENDER:

1. Bidders must submit a valid BBBEE Verification Certificate from SANAS Accredited Verification Agency / Registered Auditor approved by IRBA (in case of JV a consolidated BBBEE certificate must be submitted). The Qualifying Small Enterprise (QSE) and Exempted Micro Enterprises (EME) must submit a sworn affidavit confirming the Company Annual Total Revenue and level of black ownership which must be signed and stamped by a Commissioner of Oaths.
2. This contract will be evaluated on the 80/20-points scoring system
3. Proof of registration with National Treasury's Centralized Supplier Database (CSD) or provide a National Treasury CSD registration number e.g. MAAA0...; contractors and service providers have a responsibility to make sure that they are tax compliant. The tax status of the bidders will be verified through CSD and SARS website at recommendation stage;
4. No price quotation or competitive bids will be awarded to a person or entities who are not tax compliant, therefore prospective bidders must ensure that they are tax compliant through the validity period of the bid/quote in review
5. Telegraphic, telephonic, telex, facsimile, email or late tenders will not be accepted.
6. Prospective Service Providers must register on Kouga Municipality's Supplier database as per the registration requirements.
7. The Council reserves the right to accept any tender and, or part thereof, appoint more than one service provider, and does not bind itself to accept the lowest or any tender. The Council reserves the right to appoint any contractor.
8. The validity period for submission must be 120 days from the closing date.

9. Bids that are deposited in the incorrect box or delivered to any other venue will not be considered.
